Sir/Madam,

This is with reference to the proposal submitted by Al-Ameen Engineering College, Karundevanpalayam, Nanjai Uthukkuli Post, Erode Dist-638 104 Tamilnadu affiliated to Anna University, Chennai under the UGC Scheme for Autonomous Colleges.

The Standing Committee constituted by University Grants Commission, in its meeting held on 04.12.2019 decided to grant autonomous status to Al-Ameen Engineering College, Karundevanpalayam, Nanjai Uthukkuli Post, Erode Dist-638 104 Tamilnadu affiliated to Anna University, Chennai for a period of ten years w.e.f. 2020-2021 to 2029-2030.

The University is requested to issue necessary notification/order regarding the grant of autonomous status to the college as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 for Autonomous Colleges. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

- The programs have been granted accreditation for 3 years. AL-AMEEN ENGINEERING COLLEGE, Karundevan Palayam, Nanjai Uthukuli (PO), Erode-638104, Tamil Nadu should submit fresh online application through eNBA portal not before five months from the expiry of validity of accreditation mentioned above.
- The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to AL-AMEEN ENGINEERING COLLEGE, Karundevan Palayam, Nanjai Uthukuli (PO), Erode-638104, Tamil Nadu as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
- 7. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
- 8. A copy each of the Report of Chairperson of the Visiting Team and Evaluators' Reports in respect of the above programs is enclosed.
- 9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
